Mrs Casling emailed that she has had a good response from her request in the Parish magazine for volunteers to reinvigorate the Neighbourhood Watch system. She has spoken to Mike Russell to make sure he is alright with everything which he has confirmed.

ESCRICK BY-PASS

No developments since last meeting.

YORKSHIRE WATER

The Chair discussed the situation with the Headteacher at the school. She confirmed that a large overflow tank has been constructed in the grounds of the primary school to alleviate the flooding issue. This was carried out just before the Autumn term, and there has been no flooding issues since in the area. This was confirmed by local residents, so this matter is now deemed closed unless further flooding is seen.

The smell on Skipwith Road appears to have been resolved.

We have received a letter from Highways to Mr Forster stating that periodically they undertake a survey of the A19 using a SCANNER vehicle which uses laser profiling to determine carriageway condition. The Highways confirmed with Mr Forster that they have set aside £30,000 to re-surface this section of the A19.

Clerk to Ssnd an email end February to Highways for attention of Mr John Hodgson and request they re-patch this area.

Rubbish has been left at the bottom end of the paddock near to the A19 gate. Mr Reynolds has reported subsequent to the meeting that 'there are about twelve polythene bags of rubbish near the gate into the paddock from the A19. The bags contain leaves and sticks. I am not sure whether it is from the site and if it was put there whilst the "Pay Back" team were working on the site. There is also some bits of old turf tipped there. I suppose it is possible that someone has driven there and dumped it but I cannot see why they would. It would be relatively easy to simply burst the bags open and spread the dead leaves etc about. There is also a small amount of debris near the gate which is very clearly been dumped. This includes pieces of polystyrene, pieces of brick and rubble. It would not be an onerous job to clear it up.' Clerk to request Selby District Council Environment Department to clear this area.
